By following the below steps, Consulting Partners and ISV's can access and download their AWS Marketplace Seller Reports.

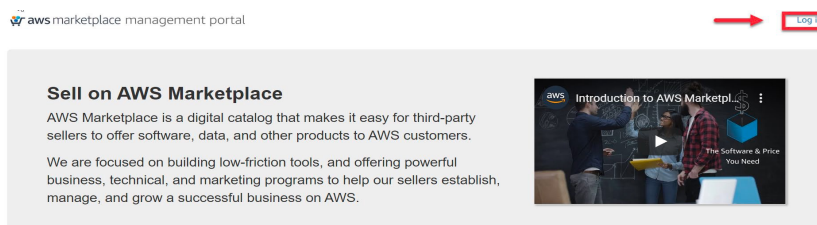
For your reference, bookmark the [Seller Reports](#) page. Click through each report's page on the left side navigation under the "Seller Reports" header to find an overview and summary.

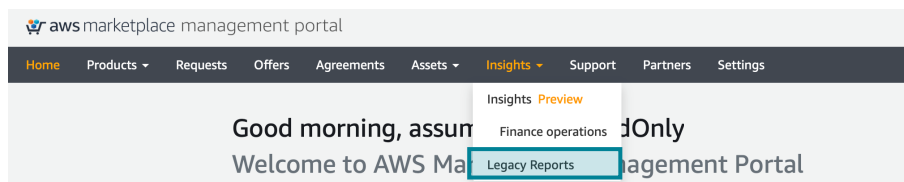

<a href="#">Monthly Billed Revenue Report</a>	Monthly report for prior month activity that shows the total amounts that AWS bills to customers for hourly, annual, or monthly usage of your products. The report has four sections: billed amounts for hourly usage and monthly fees, variable-length subscriptions, field demonstration usage, and flexible payments. <a href="#">Monthly Disbursement Report</a>	The monthly disbursement report provides information about funds that we collected and disbursed to your bank accounts since the previous disbursement. Disbursements can include customer payments or refunds for a subscription to your product, and some taxes collected or refunded to the customer. The report has seven sections: Disbursed amount by product, by customer geography, by instance hours, age of uncollected funds, age of disbursed funds, age of past due funds, Uncollected Funds Breakdown.
